

THE CHARTER OF INCORPORATION OF TOUGALOO COLLEGE NATIONAL ALUMNI ASSOCIATION, INC.

The Undersigned adult resident citizens of the State of Mississippi, acting as the incorporators of Tougaloo College National Alumni Association pursuant to the provisions of Sections 79-11-137, et seg, of the Mississippi Code of 1972, as amended, having first been duly authorized to do so by

1. The name of the corporation is Tougaloo College National Alumni Association, Inc.

- 3. The period of duration of said corporation shall be perpetual.
- 4. This is a nonprofit corporation and no shares of stock shall be issued.
